Pursuant to 28 U.S.C. § 636, the Court has reviewed the entire file de novo, including the magistrate judge's final report and recommendation, and the objections to the report and recommendation that have been filed herein. The Court agrees with the recommendations of the magistrate judge.

ACCORDINGLY, IT IS ORDERED:

1. The final report and recommendation is adopted.
2. Defendants' Motions to Dismiss are granted.
3. Plaintiff's: (a) federal civil rights and conspiracy claims against defendant LADPSS are dismissed with prejudice and his state-law claims against LADPSS are dismissed without prejudice to plaintiff raising such claims in state court; (b) claims against CDSS are dismissed with prejudice; and (c) claims against the Federal


Defendants in their official capacities, as well as his federal civil rights and conspiracy claims against defendant Robinson in her individual capacity, are dismissed with prejudice.
